## **CONTEST RULES**

### HOW TO ENTER

No purchase necessary. The University of Winnipeg Alumni "Caption This Photo Contest" begins on **December 20, 2020** at **09:00 AM** Central Time (CST) and ends on **January 25, 2021**, at **6:00 PM** CST (the "Contest Period"). To enter, simply send your name, year of graduation, degree, and the name of the place where you live, along with your photo caption to <u>alumni@uwinnipeg.ca</u>. This contest is held by the Alumni Affairs Office at The University of Winnipeg, 515 Portage Avenue, Winnipeg, MB, R3B 2E9 (The "Sponsor"). Your entry must be received within the Contest Period. Limit of one (1) entry per person during the Contest Period. All eligible entries received during the Contest Period will be entered.

1. All entries received will be verified. All entries become property of The University of Winnipeg and will not be returned, and proof of submission of any entry will not be deemed proof of receipt. Use of any automated system to enter is prohibited and will automatically result in disqualification.

### ELIGIBILITY

2. The Contest is open to all residents of **Canada**, except Quebec, who have reached the age of majority in their province or territory of residence at the time of entry.

#### PRIZES

3. Grand Prizes: There will be 1 Grand Prize available to be won, consisting of a \$100 Diversity Food Services Gift Card. Approximate retail prize value is \$100 each (the "Grand Prize").

The prize must be accepted as awarded and is not transferable or convertible to cash. No substitutions except at Sponsor's option. Sponsor reserves the right to substitute a prize or a prize component with one of equal or greater value, including without limitation, but solely in the Sponsor's sole discretion, a cash award. Prizes will only be awarded to the person whose name and email address appears on the Contest Entry.

## **DRAW AND WINNER SELECTION**

On **February 2<sup>nd</sup>, 2021**, at 12:00 Noon Central Time, at The Alumni Affairs office, located on the 9th Floor of 491 Portage Ave. (The Rice Building). **1** eligible entrant will be selected by the calculation of the most votes from all eligible entries received during the Contest Period. The odds of winning depend on the number of eligible entries received.
- 5. **Before being declared the winner:** each selected entrant must first correctly answer, unaided, a time-limited mathematical skill-testing question to be administered by e-mail or telephone. Selected entrants will be contacted by phone or e-mail, and will be required to sign and return within 10 business days of notification a declaration of eligibility and a liability/publicity release, which:
  - a. confirms compliance with the contest rules;
  - b. releases The University of Winnipeg, its affiliated companies and agents, advertising and promotion agencies, the contest judges and each of their respective officers, directors, agents, representatives, successors and assigns from any liability in connection with the Contest, the entrant's participation therein and/or the awarding and use or misuse of the prize or any portion thereof; and
  - c. grants to The University of Winnipeg the right to use the selected entrant's name, address (city only) and likeness in any form of advertising relating to the contest without further notice or compensation.

If a selected entrant: (i) cannot be contacted by e-mail or telephone within thirty (30) calendar days of selection or there is a return of any prior notification as undeliverable; (ii) fails to correctly answer the skill-testing question; or (iii) fails to return the contest documents within the specified time, he/she will be disqualified and will forfeit the prize, and the Sponsor reserves the right to select an alternate entrant from among the remaining eligible entries. Once declared a winner, the selected entrant will be directed as to how to claim his or her prize.
