CONGRATULATIONS TO M.A. STUDENTS NICOLE MURDOCH & SARA PELLAND FOR WINNING A SSHRC RESEARCH SCHOLARSHIP - MASTER'S **PROGRAM**

Nicole on her research: "In December 2023, the research I proposed for this award was titled: Intersecting Systems of Control: A Qualitative Analysis of the Birth Alert System's Impact on Indigenous Families in Manitoba. By collecting and analyzing stories from Indigenous families, along with professionals such as social workers, healthcare providers, and law enforcement, the study aims to uncover how the system functioned, how it connected to the criminal justice system, and how it contributed to systemic inequities. Additionally, my proposed research sought to provide actionable recommendations for improving child welfare and criminal justice policy."







Sara on her research: "My research will aim to explore community perceptions about policing in Manitoba's Indigenous communities, with a particular focus on the Manitoba First Nations Police Service (MFNPS). The study will involve a two part strategy, beginning with the analysis of transcript data from several major inquiries related to Indigenous Justice, such as the 1991 Aboriginal Justice Inquiry and the 1996 Royal Commission on Aboriginal Peoples, among others. My intention is to follow this analysis with conversations with those living in MFNPS served communities, centering community voices rather than relying solely on crime rates and officer opinions, both of which are more heavily relied on in Indigenous policing research. The relevance of this study is highlighted by the recent opening of an MFNPS detachment in the community of Brokenhead Ojibway, exemplifying that the use of First Nations policing is an expanding practice within Manitoba and demonstrating the need for better dialogue around policing, authority, and governance in Indigenous communities."
