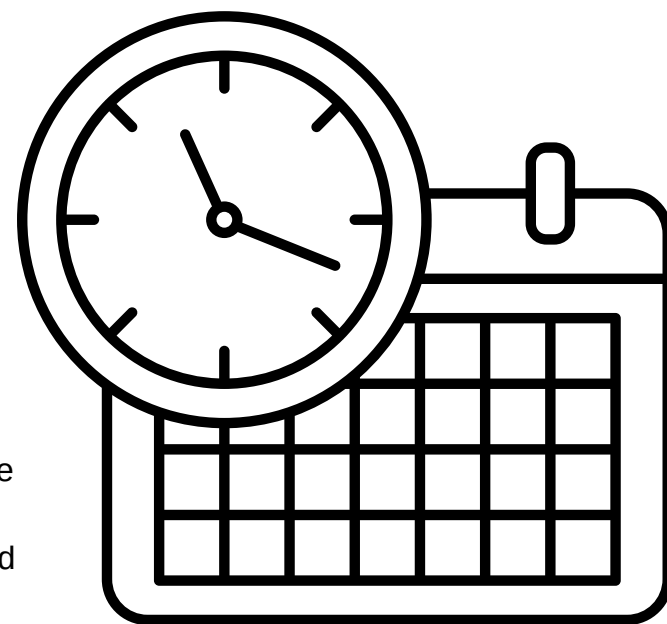

REGULATIONS RELATED TO SCHEDULING AND REGISTRATION

In order to guarantee that all students are able to fulfill their degree requirements, students will be assigned to a particular timetable of courses. By doing this, we ensure that all students are able to register for the courses they need without worrying about potential conflicts or courses filling. Students must register for the specific courses and sections to which they have been assigned. To be fair and consistent, we cannot consider individual requests to accommodate work schedules, commuting time, child care, course preferences, extra-curricular activities at the practicum school, or any other reasons for wanting specific courses or sections.

Certification Year students will receive an email with a list of their assigned courses and schedules by mid-June. Until then, students should plan to be available for classes and practicum every day, from 8:30 am – 6:30 pm. All extra-curricular activities, including work, child care arrangements, and extra-curricular activities at the host school must be scheduled around classes and practicum commitments. Students who are unable to devote this time to their studies should defer certification until they are in a position to do so. Students who are unable to attend Certification Year 4 can request to have their space in the program held for a maximum of one year. Students entering Certification Year 4 will register in Tier 2 or Tier 3, depending on how many credit hours have been completed by April 2025. Students are expected to register at their appointed time.

It is expected that students are familiar with the rules and regulations governing the education program. Ignorance of requirements and policies will not be considered in determining the validity of appeals or special requests. OVERVIEW OF CERTIFICATION YEAR 4

In Certification Years 4, students complete curriculum courses related to their streams and teaching areas. In addition, students will gain practical knowledge through courses that emphasize social justice, inclusion, and diversity. Students will integrate theory and practice through extended blocks of student teaching. Through both academic study and practicum experience, students will gain the skills they need to become competent and caring professional educators. Certification Year 4 consists of 30 credit hours. The general requirements for the Senior Years stream are outlined in the table below:

CERTIFICATION YEAR 4 CURRICULUM, INSTRUCTION, AND ASSESSMENT COURSES

In Year 4, students will take Middle Years “Curriculum, Instruction and Assessment” (CIA) courses in broad subject areas related to their teaching areas (e.g. English Language Arts, French, Kinesiology, Mathematics, Science, or Social Studies). Students will also take specialized curriculum courses in their major and minor subjects. Students will gain a thorough understanding of teaching methods in their subject areas, and will learn strategies for teaching in both middle and senior years grades.

Notes for Curriculum Group A:

There will be two sections of EDUC-4730 MY English Language Arts for Senior Years Teachers to incorporate students with teaching majors or minors in English, Classics, Psychology, Sociology and Theatre. Students will be assigned to these sections.

EDUC-4754 SY CIA: Theatre I and EDUC-4755 SY CIA: Theatre II are offered in alternating years. In 25/26, students with a Theatre teachable major or minor will take EDUC-4755 SY CIA: Theatre II. In 26/27 students will take EDUC-4754 SY CIA: Theatre I.

Students with two teaching areas in Group A (i.e. English and Theatre, English and Psychology, Theatre and Sociology, etc.) will complete a total of 9 c.h. of CIA instead of 12 c.h. in Year 4 due to teaching areas being combined in EDUC-4730 MY English Language Arts for Senior Years Teachers. Students will be assigned to an Education courses to replace 3 c.h. of MY CIA.

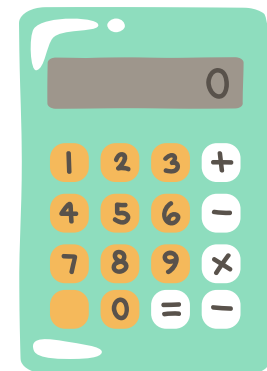
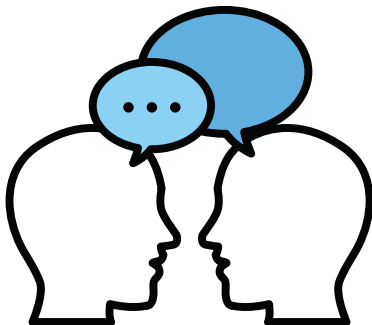
There will be two sections of EDUC-4735 MY Social Studies for Senior Years Teachers to incorporate students with teaching majors or minors in Anthropology, Economics, Geography, History, Indigenous Studies, Philosophy, Political Science, and Religion and Culture. Students will be assigned to these sections. There will be two sections of EDUC-4752 CIA Social Studies I for Geography and History. Students with both Geography and History will take both sections.

Students with 2 teaching areas in Group B (i.e. History and Classics, Geography and Indigenous Studies, etc.) will complete a total of 9 c.h. of CIA in Year 4 instead of 12 c.h. due to teaching areas being combined in EDUC-4735 MY Social Studies for Senior Years Teachers. Students will be assigned to an Education courses to replace 3 c.h. of MY CIA.

Notes for Curriculum Group D:

Students with two teaching areas in Group D (i.e. Biology and Chemistry) will complete a total of 12 c.h. of CIA in Year 4 , even though teaching areas are combined in EDUC-4869 Theory of Science Teaching and EDUC-4735 MY Science for Senior Years Teachers.

EDUC-4750 SY CIA: Physics I and EDUC-4751 SY CIA: Physics II are offered in alternating years. In 2025/2026, students with a Physics teachable major or minor will take EDUC-4751 SY CIA: Physics II. In 2026/2027 students will take EDUC-4750 SY CIA: Physics I.



OTHER CERTIFICATION YEAR 4 REQUIREMENTS

Practicum Blocks I and II

Students will complete extended practicum blocks at the end of the Fall and Winter terms. In addition, students will attend their host schools for one full day or two half days per week throughout both terms. Each practicum block is worth 3 credit hours.

Senior Years Curriculum, Instruction and Assessment – Literacy Across the Curriculum

All Senior stream students will be required to complete EDUC-4870(3) SY C, I & A: Literacy Across the Curriculum. Students will be assigned to a specific section of this course. Students with an English major or minor will not be required to complete this course and will instead be assigned an Education elective.

Introduction to Indigenous Education

All students will be required to complete EDUC-4410(3) Introduction to Indigenous Education. Students will be assigned to a specific section of this course.

Classroom Management

All students will be required to complete EDUC-4701(3) Classroom Management. Students will be assigned to a specific section of this course.

Inclusive Education II

Students in the Senior Years streams will be required to complete a course to fulfill the “Inclusive Education II” requirement. Students will be assigned to a specific course.

TIMELINE OF UPCOMING EVENTS

January 2025 - French Immersion School Placements

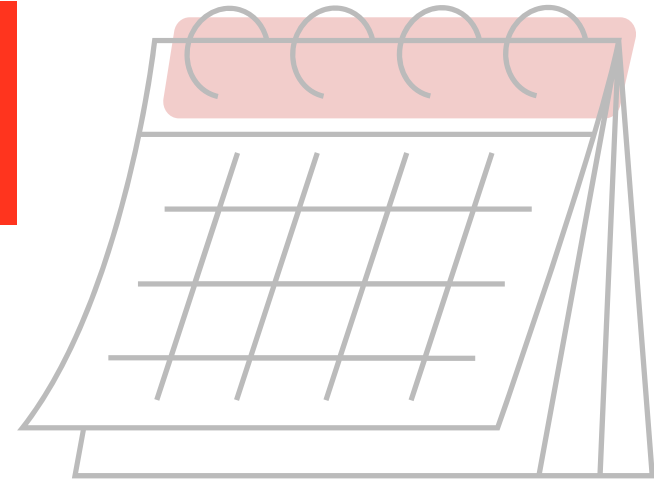
Students who wish to be placed in a French immersion school must meet an oral and written language proficiency requirement. Students who are interested in a French immersion placement must submit their names to the Student Teaching Office by January 26, 2025. We will forward the list of names to Université de Saint-Boniface (USB), where the testing is administered. USB will contact students to arrange testing appointments.

Students are advised to make a realistic assessment of their oral and written French skills. Generally speaking, students undertaking French testing should have recently completed a major in French, with a grade point average well in excess of 2.0.

May 2025 - Certification Eligibility Review

When grades become available at the end of May, your eligibility to attend Certification Year 4 will be assessed. In order to be eligible, you must have completed a minimum of 93 credit hours with an overall grade point average of 2.0, all required first, second and third year education courses, all required major courses for a BA, BSc, or BPHE with a grade point average of 2.0, a 30 credit hour teachable major and an 18 credit hour teachable minor (which may be fulfilled by the degree major). In addition, you must have completed the Academic Writing and Humanities requirements. Please consult the package that you received in December for a list of outstanding requirements that must be completed before beginning Certification Year 4. Students will have until the end of August, 2025 to meet all of the above requirements.

TIMELINE OF UPCOMING EVENTS

June 2025 - Registration Materials

By mid June, the Education Office will mail out a package of information, which will include an updated degree checklist, a list of your required courses and sections for Certification Year 4, a timetable, and a link to a Registration Information Booklet which will be posted on our website. This booklet will include detailed information and dates for Certification Year 4.

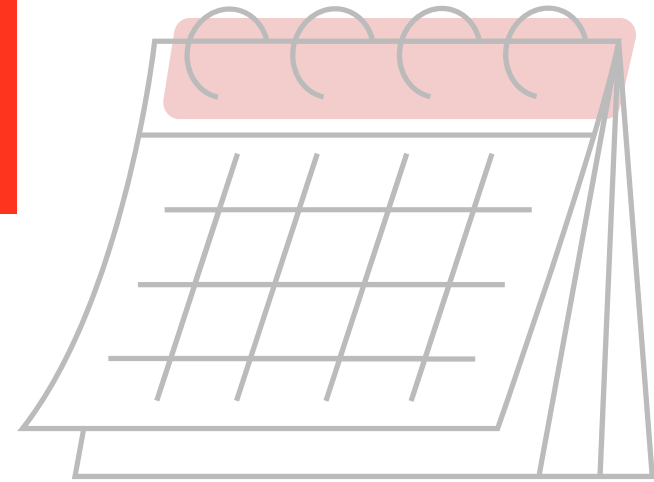
June 2025 - School Placement Notification

In June, you will receive an email informing you of your school placement. You will need to contact your school to make arrangements for the “Start of School” experience, which will take place September 2 – 5, 2025. Check the University website for the release date for practicum placement. Please remember that practicum placements are non-negotiable.

June 2025 - Registration

Registration for Certification Year 4 should take place in approximately late June. All students will be assigned an online registration start date and time for Fall/Winter 2025-2026. This information will be e-mailed to you in late May.

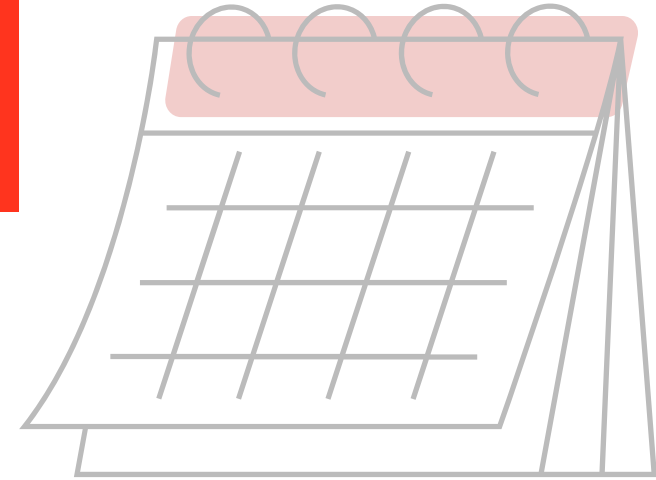
If you decide not to register for Certification Year 4, please notify the Education Office as soon as possible. If you do not attend Certification Year 4, please be advised that you must submit a written request, and receive permission from the BEd Academic Advisor to have your space in the program held. Your space can be held for a maximum of one year.



TIMELINE OF UPCOMING EVENTS

September 2 - 5, 2025 - Start of School Experience

In order to experience the beginning of the school year, you will be expected to be at your host school from September 2 - 5, 2025. Participation in the “Start of School” experience is mandatory. Students who do not attend the “Start of School” experience will have their application to attend Certification Year 4 withdrawn.



September 2025 - “Here. We Grow!” Begins

The Faculty of Education will offer a series of professional development and career exploration seminars as well as workshops and placements throughout the year for all education students. These sessions will cover a variety of topics, such as creating engaging field trips, learning about speakers available to you and your students and other opportunities to see the variety of ‘teaching’ that occurs in Manitoba schools. As well, tailored for our graduating students, Career & Hiring Fair will be offered allowing several school divisions to present information sessions on employment prospects and application procedures.

September 2025 - Practicum Meetings Begin

There will be six practicum meetings held throughout the year (three in fall and three in winter). Class meetings will be held for all Certification Years students including Integrated, After Degree and Red River College Polytechnic students at the same time. Meetings will start on Zoom at 5:30pm and conclude at 6:15pm. They will be recorded and posted on Nexus site. Meeting dates can be found under “Important Dates” at the end of this booklet.

CONDENSED COURSES AND SCHEDULING

Each term will consist of ten weeks of lectures, followed by a student teaching block. In order to accommodate the student teaching blocks, certification year courses will be offered in a condensed format, so that they can be completed before student teaching begins. Condensed courses may be offered in the Fall term, the Winter term, or across both Fall and Winter terms. Curriculum, Instruction and Assessment courses and condensed education electives will be scheduled in the two 10 week lecture blocks at the beginning of each term. These special condensed courses will be indicated by a section number in the 150s in the timetable – e.g. EDUC-4410(3)-150. Generally speaking, these condensed courses are the only courses that you can take in Year 4. Arts and Science courses offered in the regular 12 week format will conflict with your student teaching blocks. While it may be possible to take a non-condensed Arts or Science course during an evening slot, your student teaching blocks will place demands on your time and energy. The student teaching blocks will require intensive at home preparation during the evenings. You should make a realistic assessment of the work load that you will be able to manage.



SPRING TERM WORKING AHEAD

Certification Year 4 courses for the Elementary stream will not be offered in the Spring term. However, there may be Spring courses offered that can count toward Year 5. The main university timetable will be available online at <http://www.uwinnipeg.ca/index/timetable-index>. Tiered registration will begin in mid-March. Please be aware that there are limited spaces available in Spring courses. We cannot guarantee entry into any course. If courses fill, we will not be able to register students over capacity.



Course Restrictions

Sections 245, 250, and 290

WEC, CATEP, and Build From Within are separate Access programs within the Faculty of Education. Courses with a section numbers in the 240s, 250s, and 290 are reserved for students in those Access programs, and are not available to other students. Occasionally, some Access courses may be open to other students. When this is the case, Access will offer two sections of the same course. One section will be reserved exclusively for Access students, while the other section will have some limited space for non-Access students.

Section 720

Courses with a section number of 720 are reserved for students participating in the Thailand program, and are not available to other students.

5000 Level Courses

The Education department will offer a number of 5000 level courses in the Spring term. These courses are only available to students who have been admitted to the Post Baccalaureate Diploma in Education. Credit for these courses cannot be applied toward an undergraduate degree.
