## **Character of this Classification Level**

The Facilities Management Department at the University of Winnipeg is responsible for the Planning, Design, Construction, and Operation of the downtown campus that encompasses over 1.6 million gross sq. ft. within 20 buildings on 15 acres of land. Positions at this level perform all the duties involved in maintaining and developing building security systems on campus, which include but are not limited to; video surveillance systems, security cameras, video management, access control systems, intercom systems, emergency call stations, and intrusion alarm and monitoring systems. The incumbent will also be involved in the research, evaluation, and development of new and emerging technologies, and responsible for commissioning and continuous re-commissioning of all building security system. This position will work with and provide support to the building systems team.

## **Characteristic Duties and Responsibilities**

- Diagnose and resolve technical problems related to all building security systems; including but not limited to surveillance systems, security cameras and video management, access control systems, intercom systems, emergency call stations, and intrusion alarm and monitoring systems.
- Performs calibrations, preventative maintenance, commissioning, and recommissioning of all building security systems and their related devices and software.
- Evaluates, designs, installs, configures, and programs hardware and software for all building security systems used throughout the campus.
- Plans and performs system software upgrades and patches to all devices and equipment.
- Provides technical consulting, training, and serves as a technical knowledge resource for faculty and staff in all areas pertaining to building security systems.
- Assists the Controls Technician to diagnose and resolve technical problems related to building systems control and monitoring systems and perform needed repairs.

- Purchases required parts and maintains a spare parts inventory.
- Preforms other duties as assigned.

- M Class Limited Specialized Trade Electricians Licence

### **Experience:**

The incumbent must have a strong background and education in various commercially used building security systems, particularly in large system deployments, and commonly used in the education industry.

- Experience configuring, administering, maintaining and troubleshooting of a wide range of building security systems and their technologies.
- 5 years minimum directly related experience in large scale building system support including, Genetec, Bosch, DSC, Mercury, HID, Aiphone, Salto Systems, Assa Abloy, and various IP cameras.
