

MPNP- INTERNATIONAL EDUCATION STREAM

New Stream: In 2017 Manitoba Provincial Nominee Program has introduced new changes for international students who graduate from Manitoba's post-secondary institutes.

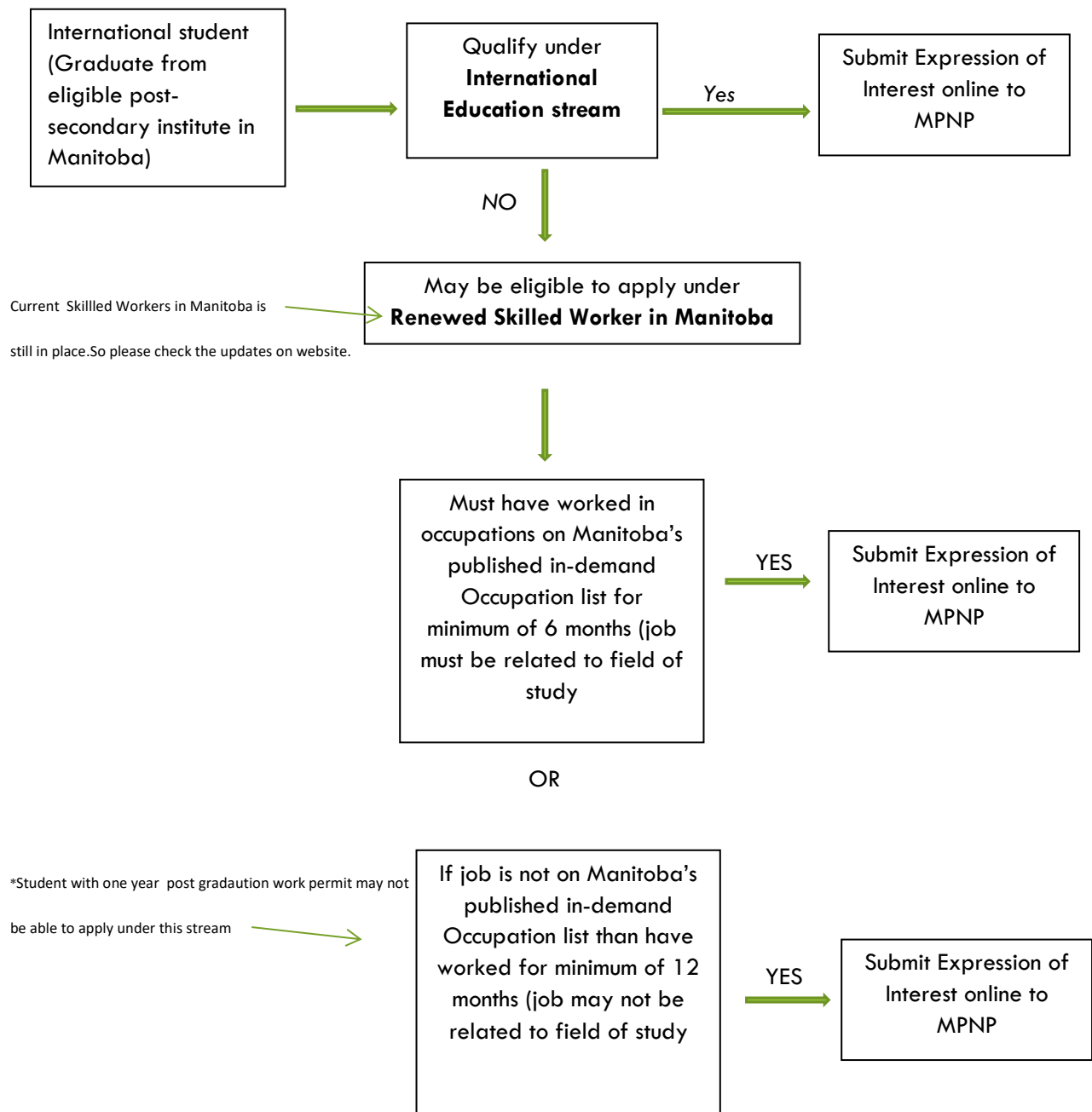
Changes have been made to facilitate faster processing of permanent residence for international students. Following has been summarized in a table to give you an idea of overall process and main requirements (there are other requirement and student should check detailed requirement for each class from the MPNP website).
