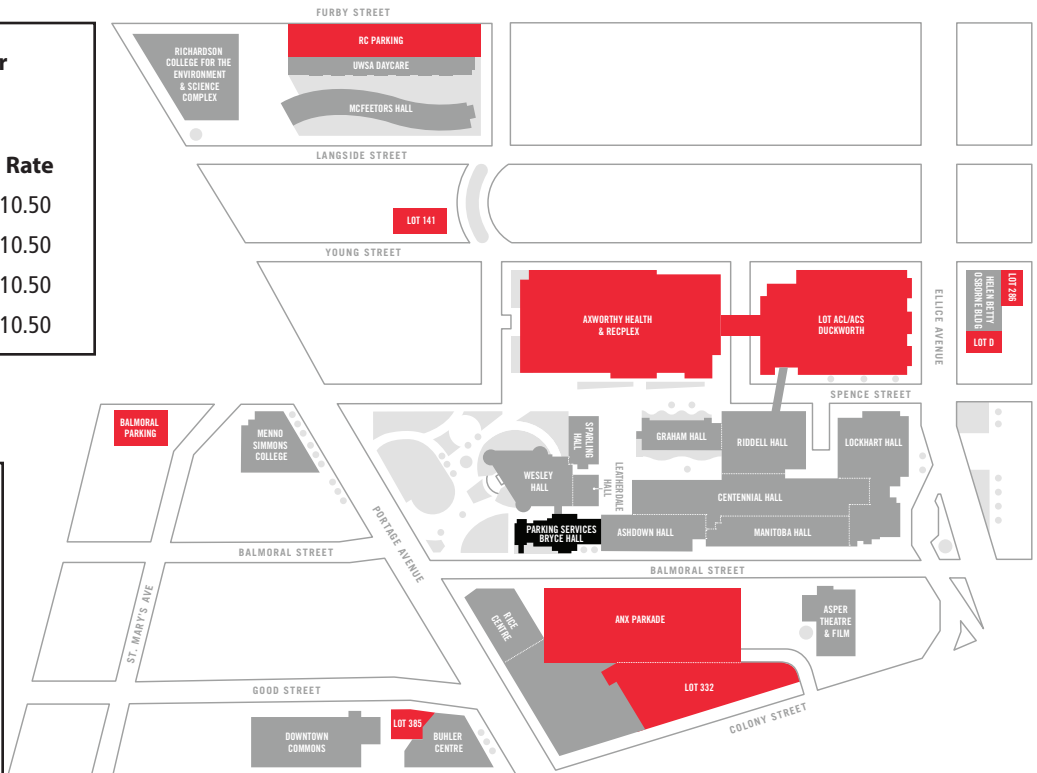

Terms and Conditions

1. This contract is for the period mutually agreed by the applicant and the parking office. This contract is NOT TRANSFERABLE.
2. The University of Winnipeg is not responsible for loss or damage to bicycle or contents.
3. Only one bicycle per application may be parked in University allocated space at any given time.
4. You must park the bicycle only in the area assigned.
5. Any change in bicycles must be reported to Parking Services as quickly as possible.
6. Except in case of emergency, maintenance and repairs to a bicycle on University property is not permitted. All waste materials must be removed promptly from University property.
7. The University is subject to market variables for off-campus spaces. Therefore this contract may be cancelled by The University with one months notice.
8. Shower facilities are available on campus. If you are not an Athletic Facility member, a \$2.00 monthly fee will be charged for this service.
9. A lost transponder/key replacement fee is \$ 20.00

WAIVER AND RELEASE OF LIABILITY

By signing this form, I freely agree to all terms and conditions and fully assume all risks, dangers and hazards that may be involved in using the facilities, including but not limited to the possibility of personal and bodily injury, death, property damage or loss. I acknowledge that the University of Winnipeg is not responsible for the theft of or damage to bicycles and/or accessories parked within or around the facilities.
