# Sexual Violence Prevention Policy

uwinnipeg.ca/respect

> Necessary to engage in any sexual activity

> Ongoing and can be revoked at any time

> Never assumed or implied (not silence, or the absence of "no") > Not possible if someone is coerced (pressured)

> Not possible if someone is incapacitated by alcohol or drugs, or is unconscious > Not possible if the perpetrator abuses a position of trust, power or authority (a boss/employee, a professor/student, a coach/athlete)

#### **Sexual Violence**

Sexual violence is any unwanted (nonconsensual) sexual act or act targeting a person's sexuality, gender identity, or gender expression.

Examples of sexual violence include:

> Physical — kissing, touching, or sex without consent > Verbal — whistles, jokes, persistently asking someone for a date

> Non-verbal — leers (suggestive staring), unwanted attention or sexual advances, offensive gestures > Written — posting pictures, sexual email or texts without consent

## Who Does the Policy Apply To?

The policy applies to everyone within the UWinnipeg Community — including anyone who works, studies, or lives on campus — and visitors to the UWinnipeg campus.

## Where Does the Policy Apply?

The University may investigate a report against any UWinnipeg community member (student, staff) whether the incident occurs on or off campus (including via social media), or incidents that occur on University property, or at an event or during an activity related to the University.

Any member of the UWinnipeg Community who has experienced sexual violence may access support, accommodations, or other resources, even if the incident takes place outside of campus.

## What Are the Time Limits?

There is no time limit for reporting sexual violence, or receiving supports, although early reporting is encouraged.

## **Options for Reporting**

Filing a report after experiencing sexual violence is your choice. You have options around reporting, including filing anonymous reports. You can still receive medical and mental health support without filing a report.

Use this tool for reporting online. You can work on a report at your own pace and choose who receives the report (UWinnipeg, the police, etc).

You can also provide anonymous reports.

#### **Third-Party Reporting**

The Winnipeg Police Service, in partnership with community agencies, offers an option for anonymous third-party reporting.

Third-party reporting allows a survivor to report an assault to a community agency, which will pass the report on to Winnipeg Police or the RCMP.

You can access third-party reporting through Klinic, Ka Ni Kanichihk, or Sage House.
