This is a homecoming for us, after our wonderfully diverse Colloquiums in Kenora, St. Louis, and Rocky Mountain House. We look forward to showing off our Centre and the University and its resources, and all the good things around us—most notably the Hudson's Bay Company and Manitoba Archives, only three blocks from our university's front door.

This expedition is separately priced, and numbers are limited. We are also looking into possibilities of other post-colloquium tours, again separately priced and organized.





Recent Acquisitions

Three post journals for the HBC post at Fort Good Hope, for the years 1875-1877, 1881-1882 and 1888-1890 have been donated to HBCA by a greatgreat granddaughter of the HBC clerk and later Chief Trader, Charles Philip Gaudet, who was employed at Fort Good Hope from 1863-1911. His son, Joseph Leon Gaudet, was post manager there from 1908-1915. Post journals, which document daily weather, work done by staff, the trade, visitors and significant events are among the most heavily used series of records in the HBCA, making them a valuable addition to our holdings. They also add to the body of records related to the operation of the post at Fort Good Hope, which includes correspondence, reports, accounts, photographs, maps and plans. In addition, HBCA has records of employment, photographs, and documentary art for Charles Philip

Gaudet and his sons, who also worked for HBC, and photographs of Charles' Métis wife and family.



Fort Good Hope, situated on the Mackenzie River, was operated by the HBC from 1821 until 1987 when, as part of the northern stores division, it was sold to the present day North West Company. Canadian Museum of Civilization Exhibits HBCA Fur Trade Records



HBCA has loaned to the Canadian Museum of Civilization (CMC) in Hull several iconic records for its exhibition: Profit and Ambition: The Canadian Fur Trade 1779-1821, which opened 11 September 2009 and runs to 12 September 2010. These include early nineteenth century voyageur contracts, the Selkirk Deed and map of 1817, a plan of York Fort by James Isham dated 1743 and the North West Company ledger, containing employee accounts for 1811-1821. Rupert's Land members will be pleased to hear that *Keepers of the Record*, the first comprehensive look at the history of the development of the Hudson's Bay Company Archives is into its second printing. Keepers of the Record has received several awards and recognition since its launch from the Archives of Manitoba in November 2007. They include the Association for Manitoba Archives Manitoba Day Award, May 12, 2008 and Society of American Archivists the Waldo Gifford Leland Award in San Francisco in August 2008. *Keepers of the Record* also received honourable mention in the 2007 John Lyman Book Awards presented by the North American Society of Oceanic History and numerous other positive reviews.

Announcing This Year's Harington Fellow

Our 2009-2010 Harington Fellow is well known to many of our members. Anne Lindsay, who has worked in the Rupert's Land office for more than five years, is pursuing, with the assistance of the Harington Fellowship and a Joseph-Armand Bombardier Canada Graduate Scholarships Program Master's Scholarship (SSHRC) a Master's degree in Archival Studies through the University of Winnipeg/University of Manitoba Joint Master's Program.

While working in the Rupert's Land office and taking undergraduate courses at the University of Winnipeg, Anne has had the opportunity to

research and publish work on a variety of subjects, including community histories (Pimicikamak and Fox Lake), material culture (an article on quill dyeing co-written with Roland Bohr and originally presented at the Northern Plains Conference in 2008 has been accepted for publication in Material Culture), and biography (she has written a number of biographies for the Manitoba Historical Society, and presented a paper at the 2008 Algonquian Conference on the Treaty Five Pimicikamak leader Tapastanum). The first part of a two-part article on Winnipeg history has been published in Manitoba History.

Anne held The University of Winnipeg Undergraduate Research Award in the Human Sciences, 2003, and received an Association for Manitoba Archives Award, in 2008. She is a contributor to Telling Our Stories: Omushkego Legends and Histories from Hudson Bay, Broadview Press, 2005, and is currently working on an atlas plate relating to the Selkirk Treaty for an Aboriginal atlas project with the Treaty Relations Commission of Manitoba. She remains active in the community, including work with the Manitoba Living History Society, and particularly enjoys her work helping students, members, and the public with research at the Centre.

Deadline for Proposals is 11 December 2009.

The Program Committee is seeking a broad array of presentations in all relevant disciplines from scholars and non-academics alike. See the detailed Guidelines below for preparing and submitting the different types of proposals. All papers will be 20 minutes in length with an additional 5 minutes for discussion. Organized Sessions will consist of 3 papers, 6 papers, or 5 papers plus one discussant. Proposals must fit into one of those formats. All <u>Proposal Forms</u> must be received in the Centre for Rupert's Land Studies office by 11 December 2009, in order to be considered. Proposals will be received by email as well as regular post, but please in either case ensure that your proposal was received by the Centre. Note: All papers will be presented on either Thursday, May 20 or Friday, May 21, with a possible third day May 22 in 2010.

Guidelines and Instructions for Multiple Authorship:

Although individuals may be authors on more than one paper proposal, no author may present more than one paper. We therefore make a distinction between "authors" and "author/presenters." In cases of multiple authorship, each "author/presenter" must fill out a separate Proposal Form, but additional "authors" who will not be presenting need not. In the section marked "Additional Authors" on the <u>Proposal Form</u>, please indicate in parenthesis the order the names should appear on the program, as well as whether the author is also a presenter. For example, if your name should appear second on the program and you have a third author who will not be presenting, then enter the first author/presenter's name, e.g. John Smith (Author/presenter 1), followed by your name (Author/presenter 2), and your third author, e.g. Jane Doe (Author 3).

A. Individual Papers (to be assigned to a session by the Program Committee):

On page 1 of the <u>Proposal Form</u>, provide your contact information, select "Individual Paper," give your Paper Title, and Additional Authors if applicable (see above). Please also provide *three keywords* for your paper and indicate your essential A/V needs if any. Please note that the committee cannot guarantee that all AV needs can be met, and some requests for equipment may be reviewed on a case-by-case basis. Please note that the Program Committee reserves the option of assigning Individual Papers to the most appropriate topical session. On page 2, provide your name, affiliation, and a biographical statement, as well as the title and abstract of your proposed paper. *Do not fill out Page 3*.

B. Papers within an Organized Session:

If a Session Organizer is proposing your paper as a component of his or her Organized Session Proposal, then *you must also submit a <u>Proposal Form separately</u>. On page 1, provide your contact information, select "B. Organized Session Paper," give the Organized Session Title, and your Paper Title. Use the slot marked, "Additional Authors," to provide the Session Organizer's name (followed by "Session Organizer" in parentheses). Also use this slot to list additional authors if applicable (see instructions above). On page 2, provide your name, affiliation, and your biographical statement, as well as the title and abstract of your proposed paper. <i>Do not fill out Page 3*.

C. Organized Sessions:

If you are a Session Organizer, use the <u>Proposal Form</u> to submit a proposal for your session. In addition, each of your proposed presenters must submit a <u>Proposal Form</u> (see B. above). *It is your responsibility to see that they do so on time*. On page 1 of your form, provide your contact information. Select "C. Organized Session Proposal," give the Organized Session Title, and provide *three key words*. A/V requests will not be considered here because they are included in the Organized Session Paper proposals (see B. above). On page 2, provide your name, affiliation, and your own biographical statement, as well as the title and abstract of the Organized Session. In the first slot on the top of page 3, indicate your name and affiliation. Use the second slot for that of the proposed Chair, if different. In the following six slots, list three, five or six individual presenters and their paper titles. If the session consists of three papers, then leave the last three slots blank. If there are five papers, fill in the final slot with a discussant and his or her affiliation. If there are six papers, then the sixth slot will be filled with a presenter and paper title.

D. Submitting your proposal:

You may submit your proposal by regular post or by email as an attachment to the addresses below. Please note that once your proposal is received, *you will receive confirmation*, either by email or post depending on how you submitted your proposal. *Presenters will be asked to pre register for the Colloquium to hold their place on the program*.


"Creating Nations and Building States: Past and Present"

Opening of the H. Sanford Riley Centre for Canadian History

October 19 marked the opening of the H. Sanford Riley Centre for Canadian History at the University of Winnipeg. Profit and Ambition: The Canadian Fur Trade, 1779-1821

Don't let the painting by Frances Ann Hopkins fool you, *Profit and Ambition* is an exhibition on the North West Company's fur trading activities between 1779 and 1821. The exhibition opened at the Canadian Museum of Civilization on 11 September, and will be showing there until 12 September 2010. Some 250 artefacts and works of art are on display, including trade goods, original documents, Native and European garments, and a birchbark Montreal canoe measuring ten meters long.

Papers of the 39th Algonquian Conference




Memories, Myths and Dreams of an Ojibwe Leader*

No Tame Cat: Fur Trade Daughter, Her Cape Horn Sea Captain and the Chilean Courtesan

Robert Harvey spent over forty years researching this historical fiction, drawing from family history and documents in the Hudson's Bay Company Archives. The novel weaves together stories of the fur trade, the Hudson's Bay Company, the maiden voyage of the HBC barque *Lady Lampson*, and life at sea. Following the marriage of retired Chief Trader Alexander Caulfield Alexander's daughter, Agnes, to Captain James Gaudin in 1873, Harvey take the reader from the central coast of British Columbia to Jersey, London and Valparaiso, Chile where Harvey introduces the reader to a Chilean courtesan, a mysterious character evoked by cryptic entries in the ship's log. *No Tame Cat* is published by Ptarmigan Press. Letters from Rupert's Land, 1826-1840: James Hargrave of the Hudson's Bay Company Edited by Helen Ross


"Rich source material for readers interested in migration literature, social history, religious studies, women's studies, and the history of the fur trade..."


