As Chair of the ICR Committee, I am honoured to present this annual report to Senate for 2020-2021. The ICR Committee is now at the end of its 3rd year (first meeting was on January 25, 2019) and the ICR is at the end of its 5<sup>th</sup> year (implemented in 2016-2017). As can be seen in the previous and current ICR Committee's Reports to Senate, the ICR Committee has been working beyond the narrow initial terms of reference. To address this, on March 22 the Committee submitted, to the Ad Hoc Senate Standing Rules Committee, a document outlining proposed changes to the terms of reference (Membership and Duties) of the Indigenous Course Requirement Committee.

# The following courses were recommended to Senate for ICR designation:

#### ANTH-1005/3 Introduction to Cultural Anthropology Indigenous Focus

New Course (Converted Experimental to New). Previously approved as an ICR course when it was submitted as an experimental course. Was submitted to convert from experimental to new. The ICR Committee re-reviewed and reapproved.

Prerequisite: None.

## ANTH-2103/3 Ethnography of North American First Peoples

Revision to Existing Course. Previously approved as an ICR course. Revisions were made. The ICR Committee re-reviewed and re-approved.

Prerequisite: None.

## ANTH-3162/3 Social Enterprise in the Indigenous Context

New Course (Converted Experimental to New). Initially offered as an IS course, migrated to Anth. and submitted as a New Course in Anth. The ICR Committee reviewed and approved.

Additional requirement: 30 credits in any subject.

HIST-3833/3 From the Reel to the Digital: Indigenous Film and New Media Art

Existing course submitted for approval as an ICR course. The ICR Committee

reviewed and approved.

Prerequisite: None.

IS-2012/3 Indigenous Sciences Contributions to Contemporary Challenges

Experimental Course. The ICR Committee reviewed and approved.

Prerequisite: IS-1016 or IS-1017.

IS-2060/3 Ago'idiwinan miskwaadesi-miinising (Treaties of Turtle Island)

New Course (Converted Experimental to New). Taught 4 times as experimental.

Submitted for approval as an ICR course. The ICR Committee reviewed and

approved.

Prerequisite: None.

IS-2402/3 Indigenous Representation in Film

Existing experimental course submitted for approval as an ICR course. The ICR

Committee reviewed and approved.

Prerequisite: None.

IS-3204/3 Gibiindwewesijigemin: Documenting Indigenous Languages

New Course. The ICR Committee reviewed and approved.

Prerequisite: IS-1101 or IS-1201.

IS-3535/3 Indigenous Gender Identities

Existing experimental course submitted for approval as an ICR course. The ICR

Committee reviewed and approved.

Prerequisite: None.

SOC-2105/6 Race, Ethnicity and Indigneous Relations. Revision to Existing course, submitted

for approval as an ICR course. The ICR Committee reviewed and approved. Prerequisite: SOC-1101 (Declared majors in Indigenous Studies may have the requisite waived by obtaining permission of the Sociology Department Chair).

We noted in the review process that the ICR consult should be modified to indicate the current status of the course seeking approval as an ICR course (for example, is the course an Existing Course, Experimental course, New course, Experimental course being converted to New, previously approved ICR course being Revised or converted to New). The ICR Committee is in the process or reviewing this issue.

We also noted that the Committee could benefit from a Policy and Procedures document and a sub-committee was established to begin this process. Members of the sub-Committee: Mary Jane McCallum (Chair), Julie Pelletier, Lorena Fontaine, and Mark Ruml.

The following courses were approved as meeting ICR requirements for student requests for recognition:
