Re: Annual Report of the Senate Curriculum Committee (2022)

As Chair of the Senate Curriculum Committee (SCC) I am pleased to provide this annual report to Senate for activities completed between June 2021 and April 2022. During this time, the SCC approved the following:

- Experimental Courses 42 credit hours
- Inactive Courses 39 credit hours
- 1 student-designed major entitled, "Urban and Community Planning for Equity"

The committee recommended the following courses be approved by Senate.

- New Courses 168 credit hours
- Course Revisions 375 credit hours
- Course Deletions 92 credit hours

Finally, the Committee supported the recommendation of the Indigenous Course Requirement (ICR) committee that Senate designate 11 courses as meeting the ICR designation. Those courses are:

- ANTH-1005 (3) Introduction to Cultural Anthropology: Indigenous Focus
- ANTH-2103 (3) Ethnography of Indigenous Peoples in Canada and the US
- ANTH-3162 (3) Social Enterprise in the Indigenous Context
- HIST-3613 (3) Native American History to 1850
- HIST-3614 (3) Native American History from 1850 to the present
- HIST-3833 (3) From the Reel to the Digital: Indigenous Film and New Media Art
- IS-2060 (3) Ago'idiwinan miskwaadesi-miinising (Treaties on Turtle Island)
- IS-2402 (3) Indigenous Representation in Film
- IS-3204 (3) Gibiidweweijigemin: Documenting Indigenous Languages
- SOC-2105 (6) Race, Ethnicity, and Indigenous Relations
- THFM-1003 (6) Introduction to Theatre: Indigenous Performance

In total, the Committee reviewed or approved 716 credit hours, and consulted on eight program changes, as approved by Academic Planning.

This was a significant increase in workload from the previous year (see Table 1), but not the highest workload over the past five years.

Other Activities

In addition to our regular activities the SCC

- Provided feedback to the committee reviewing the Senate Standing Rules
- Organized, and co-hosted a webinar with Academic Planning to provide guidance to for those interested in understanding program and curriculum guidelines. Funded by Senate, this webinar included presentations by Colin Russell, Glenn Moulaison, Doug Goltz and Patricia Fitzpatrick. Seventy-seven (77) registered for and 69 attended *Navigating Academic Planning & Curriculum Processes*. The video, which has been viewed 19 times, is available at https://www.uwinnipeg.ca/arts/faculty-and-staff-forms/curric-forms.html. Special thanks are extended to Jackie Benson, Terri Einarson Breber, Bryce Brennan, and Marina Britten for helping with the event.

We recommended a similar event be hosted every two years.

- Provided input into Academic Planning's policy on multi-level courses.
- Initiated a process to update the SCC forms. In November 2021, we struck the SCC Forms ad hoc
 Working Group with membership from Student Services, Scheduling, Accessibility Services, the
 Registrar's Office, the Library, Academic Planning, Communications and the SCC. The Working
 Group and the SCC provided feedback with respect to the content and output style/presentation
 of the SCC forms. Eric Roddy, from Communications developed a new set of forms. This material
 will be submitted as part of the May 2022 Senate Package.

The SCC would like to extend our thanks to Eric Roddy, and the members of the Working Group for their work on this initiative.
