As Chair of the ICR Committee, I am honoured to present this annual report to Senate for 2021-2022. The ICR Committee is now at the end of its 4th year (first meeting was on January 25, 2019) and the ICR is at the end of its 6th year (implemented 2016-2017).

As can be seen in the previous ICR Committee's Reports to Senate, the ICR Committee had been working beyond its initial terms of reference. To address this, on March 22, 2021 the Committee submitted, to the Ad Hoc Senate Standing Rules Committee, a document outlining proposed changes to the terms of reference. Members of the SSR Committee were extremely collegial and easy to work with throughout the consultation. It was decided that, for the time being, the ICR Committee should proceed following the initial terms of reference. As a result, we did not host a Fall or Spring Workshop for ICR Instructors.

Dr. A. Curren: CJ 2100-003/004 Foundations of Criminal Justice (\$200).

Funding amounts of applicants were reviewed to ensure that honorariums align with the new Elder Protocols approved by Senate in May 2020.

Monitoring ICR Institutional Analysis and related research:

The Committee reviewed the *Indigenous Course Requirement Course Registration and Capacity Analysis: End of Year 5 Report* by Institutional Analysis (IA).

A couple of things were discussed at our meeting: One, IA should identify which instructors are Indigenous 2) the high amount of CAS teaching ICR courses is a bit disconcerting and speaks to the need to hire more Indigenous faculty.

Other Activities:

A Policy and Procedures sub-committee was formed and met 5 times. A document was scheduled to be presented to the ICR Committee at the June, 2021 meeting but it was tabled until our next meeting and tabled again until the new members joined the Committee and the

vacant position in the ICR Committee was filled. Julie Pelletier, Marc Kuly, and Jeannie Kerr's terms ended June, 2021 and Mary Jane McCallum resigned on September 13, 2021 (her term was scheduled to end June, 2022). As of April, 2022 we have a full committee and have resurrected the Policies and Procedures document for discussion.

Current Activities:

We are currently discussing suggested changes to the ICR consult form. Senate Curriculum Committee is in the process of reviewing Senate forms. The ICR Committee will be meeting in May to finalize our recommended changes and forward these on to the SCC Chair.

The previously tabled Policies and Procedures document, which has some relevance to the discussion related to the ICR consult form, will be presented to the Committee at our May, 2022 meeting.

Closing Statement:

I would like to acknowledge and thank the outgoing Committee members (Jeannie Kerr, Marc Kuly, Mary Jane McCallum, and Julie Pelletier) for their hard work, long hours, positive energy, and commitment, and welcome our new members (Nora Casson, Jan DeFehr, Chantal Fiola, and Melanie O'Gorman).

The dedicated members of this Committee, strongly believing in the ICR and Indigenization, contributed to the deliberations and functioning of the ICR.

Our Committee is fortunate to have Ramona Hallett (former Coordinator for Indigenous Academic Lead and now Administrative Officer, Office of the Associate Vice-President, Academic), keeping us on track.
