# **COURSE DESCRIPTION**

THFM-1001: INTRODUCTION TO THEATRE: PERFORMANCE is designed as an introduction to the basic concepts of theatre with an emphasis on the art and craft of the performer. While the emphasis will be on the development of acting technique, this course is an introduction to theatre in the grander sense, and so time will be spent examining the interrelationship between the various creative roles in the theatre, as well as developing a process of textual analysis from the perspective of an interpretive artist and introducing the student to a small sampling of dramatic literature: specifically *Bang Bang* by Kat Sandler, *New World Brave* by De Ba Jeh Mu Jig and *Tough* by George F. Walker. The students' understanding of these plays and other class readings will be evaluated through brief written quizzes.

In the Fall Term students will be introduced to the basics of modern acting technique through the lens of improvisation and through clown-based approaches to character development. Improvisational exercises will be used to establish and practice the fundamentals of acting. The students' progress will be evaluated through two performance presentations: first through an improvised presentation and second through the rehearsal and performance of a monologue. In the Winter Term the students will carry-over this character work and improvisational approach to scene work and increasingly more challenging dramatic narratives. Students will be required to perform one collective scene and one substantial, rehearsed scene selected from modern or contemporary works. In-class work will focus on script analysis, technique development and rehearsal skills. **Students are required to bring a notebook and pencil to all classes and rehearsals.** 

Over the course of the academic year, students will attend three (3) live productions. In the first term we will attend the Royal Manitoba Theatre Centre's production of *Bang Bang* at the Tom Hendry Warehouse (runs from Oct 3-19), and *The Wedding Party* at the Prairie Theatre Exchange (runs from Nov 20-Dec 8). In second term we will attend Royal Manitoba Theatre Centre's *New Canadian Curling Club* (runs Feb 12-Mar 7). Attending these three evenings of theatre is a course requirement.

Mandatory "one-on-one" interviews will be held in the exam period at the end of each term. Failure to attend will be counted as an absence and marks will be deducted as per the attendance policy. Alternate arrangements will be made for students hoping to leave town before either of these dates; speak to the professor about your specific situation well in advance.

Class communication will take place via email. Students are encouraged to regularly check their uwinnipeg email accounts for information and updates from the University.

### **REHEARSALS**

During the Fall Term, students will be required to meet to practice the improvisational exercises introduced in class. This requirement will involve from one to two hours of out-of-class work per week. During the Winter Term all students will be required to take part in continuous ongoing scene rehearsals outside of scheduled class time. This requirement will involve a <u>minimum</u> of two to four hours per week. Students unable or unwilling to comply with this requirement are asked to withdraw from the course immediately.

Any student who repeatedly misses rehearsals, comes late, or fails to rehearse adequately may be asked to withdraw from the course. This includes scheduled in-class rehearsal periods. This provision has been established to protect the educational interests of scene partners and other classmates.

Scenes must be approved by the instructor **PRIOR** to the start of the allotted rehearsal period.

### **ASSIGNMENTS: A GENERAL OVERVIEW**

Performance

There are four performance assignments in INTRO TO THEATRE: PERFORMANCE. In the fall term: Performance 1: Something Fantastic (M Oct 21), and Performance Project 2: Character Body Monologue (Mon Dec 3). In the winter term: Performance Project 3: Scene Pool (Mon Feb 10) & Performance Project 4: Final Scene (M Mar 30). The material for this scene will be taken from the modern/contemporary canon.

• Written

Each student will prepare a **written analysis** of their Scene Pool scene and Final Scene. The analysis process will be based on the methods addressed in *A Practical Handbook for the Actor, Backwards and Forwards* as well as further material provided by the professor. Due Dates: M Feb 10 (Scene Pool), M Mar 30 (Final Scene) – as part of the Process Paper assignment.

Each student will also submit a **Process Paper** on their Scene. This paper will include dramaturgical research, a scene breakdown, the play/scene analysis and a reflection on the experience of applying technique, rehearsing and performing the scene. Due Date: M Mar 30.

Quizzes

There will be two (2) tests and four (4) quizzes during the year to evaluate students' understanding of the material covered. These will focus on comprehension from the ACTOR'S point of view. Dates: M Sept 23 (Bang Bang Quiz), M Nov 4 (New World Brave Quiz), M Dec 2 (Backwards and Forwards Test), M Jan 6 (Tough Quiz), M Feb 24 (Practical Handbook Test), M Mar 23 (Actor's Terminology Quiz).

Regarding **Pass/Fail (P/F)**: A number of the performance assignments include a pass/fail component. This component is a necessary part of the process. If the student fails this component it will result in a 10% reduction in the final grade for the assignment.

Regarding the Fall & Winter Participation Grades: First - success in participation is not based on being an extrovert. This course is a practical studio course, with some lecture/discussions, and we'll do a number of things that will push students out of their comfort zones. The expectation is that, despite this, students will commit themselves to the in-class work and assignments, and will test the benefits of our work through trying it – fully. Students are also expected to participate actively in discussions – though the quality of a student's contributions matters more than the quantity. Theatre is a collaborative artform that relies on the commitment of all the collaborators. This commitment needn't be uncritical, but it does need be generous and benevolent.

## **CLASS PARTICIPATION**

Class participation includes:

- preparation; line-learning; attendance; punctuality
- meeting outlined deadlines for in-class activities
- committed participation in class activities and discussions\*

## **LATE ASSIGNMENTS**

Deadlines for practical assignments are non-negotiable, except in emergency situations.

Papers will **NOT** be accepted after the due date. Extensions may be granted but only BEFORE the due date and with a valid reason, at the professor's discretion. **N.B. It is the student's responsibility to retain a photocopy or virtual copy of ALL assignments submitted for grading; in the event of loss or theft, a duplicate copy is required.** 

Should a student be absent (unexcused) on the day of an assigned performance, the student will receive **0%** for that assignment. Should that student's absence affect a scene partner or partners, alternate arrangements will be made for their evaluation.

## **DRESS REQUIREMENT:** \*\*All apparel must fit well, and allow for ease of movement

As many of our classes are physical in nature, students are asked to wear comfortable clothing. Outdoor footwear must be removed before entering the studio. Please observe the following guidelines:

No low-rise pants, overly baggy pants or street shoes or hats

T-shirts or leotards (a fair bit of time may be spent on the floor so low-cut tops are a bad idea)

# **ATTENDANCE AND LATENESS (for first-year Performance classes)**

Given that this is a practical studio course, extensive participation and professionalism are required. As a result, punctuality and attendance at class and at out-of-class rehearsals are of the utmost importance.

- Unexcused absences from lectures, labs, or out-of-class rehearsals will be penalized at a rate of 1% per instance.
- Unexcused lateness for lectures, labs, or out-of-class rehearsals will be penalized at a rate of .5% per instance.
- Attendance and punctuality will be recorded at the beginning of every class.
- After a **THIRD** late or absence, the instructor will schedule a meeting with the student to discuss withdrawal from the course.
- After a <u>FIFTH</u> unexcused absence the student will be required to meet with the Chair of the department to discuss withdrawal from the course.
- Excused absences or lates require a medical note or prior arrangement with the instructor. It is at the instructor's discretion whether or not to excuse a non-medical absence.
- After <u>FIVE</u> excused absences the student will be required to meet with the Instructor to discuss whether it is realistic for him/her to continue in the course.

Given the rigorous, practical nature of studio courses, and the demands these courses make in terms of attendance and punctuality, students with chronic medical conditions that require extensive absence should meet with the instructor at the beginning of the term to discuss whether the course is appropriate for them.

This series will feature speakers from a range of areas in the performing arts: technical, performance, design, management, film, directing, playwriting, etc. These speakers will specifically address issues related to "the business of the business."

Attendance at <u>ALL</u> lectures is <u>MANDATORY</u> for <u>ALL</u> Honours students in Theatre (4000-level courses, all areas), <u>as well as</u> students in: THFM-3101 Acting III: General, THFM-3201 Styles in Design, and THFM-3801 Production II. Penalties for absence may be assigned by individual instructors.

Attendance for potential Theatre Honours/Majors and for Film Majors is optional but highly recommended.

## **NOTES FOR PERFORMANCE COURSES**

- Rehearsals for final presentations and public exercises are scheduled well in advance; students
  must arrange their university and work schedules so as not to conflict with them. Students must
  attend ALL scheduled rehearsals.
- Any student who repeatedly misses rehearsals, comes late, or fails to rehearse adequately will be asked to withdraw from the course (see Attendance note, above).
- As many of our classes are physical in nature, students are asked to wear comfortable clothing.
- Outdoor footwear <u>must be removed</u> before entering <u>ANY</u> of the Studios: **0T09** (Concourse Studio), **0T19** (Mime Lab), **1T15** (Theatre), **2T05** (2nd Floor Studio), **2T15** (Movement Studio). We suggest you bring suitable dance shoes or slippers to wear in class. Your professors will monitor and enforce this regulation in order to preserve the integrity of the special flooring in these rooms. Please respect this rule.
- Student actors, like professionals, are expected to provide their own basic makeup supplies where required for public exercises. Due to the potential for the transmission of skin diseases it is not recommended that students share makeup.
- Senior acting students scheduled to perform in a departmental public exercise are asked not to modify their hair colour or style without first checking with the instructor/director.
- Students who bring props, costumes, or furnishings to support scene presentations please note:
- the University will **NOT** be responsible for the loss of any such materials;
- students are responsible for the <u>IMMEDIATE</u> removal of such materials after <u>EACH</u> use the department does not provide storage;
- materials not claimed <u>WILL BE DISPOSED OF</u> at the student's expense. Grades may be withheld until such costs are recovered;
- students <u>MUST NOT</u> move existing furnishings from their current locations.

- Cellular phones <u>MUST</u> be turned off during classes and examinations; texting is <u>NOT</u> permitted in class.
- Any student attending a test or final examination may be required to present proof of identity; photo identification is preferred.
- It is the student's responsibility to retain a photocopy or computer disk copy of <u>ALL</u> assignments submitted for grading; in the event of loss or theft, a duplicate copy is required.
- When it is necessary to cancel a class due to exceptional circumstances, instructors will make
  every effort to inform students via uwinnipeg email (and/or using the preferred form of
  communication, as designated by the instructor), as well as the Departmental Assistant and
  Chair/Dean so that class cancellation forms can be posted outside classrooms. Students are

reminded that they have a responsibility to regularly check their uwinnipeg e-mail addresses to ensure timely receipt of correspondence from the university and/or their course instructors.

- Misuse of Filesharing Sites. Uploading essays and other assignments to essay vendor or trader sites (filesharing sites that are known providers of essays for use by others who submit them to instructors as their own work) involves "aiding and abetting" plagiarism. Students who do this can be charged with Academic Misconduct.
- Avoiding Copyright Violation. Course materials are owned by the instructor who developed them. Examples of such materials are course outlines, assignment descriptions, lecture notes, test questions, and presentation slides. Students who upload these materials to filesharing sites, or in any other way share these materials with others outside the class without prior permission of the instructor/presenter, are in violation of copyright law and University policy. Students must also seek prior permission of the instructor /presenter before photographing or recording slides, presentations, lectures, and notes on the board.
- Students conducting research interviews, focus groups, surveys, or any other method of
  collecting data from any person, including a family member, must obtain the approval of the
  appropriate ethics committee before commencing data collection. Exceptions are research

## STUDENT PARTICIPATION POLICY & COURSE CONTENT

Theatre is a communal art form in which a number of interdependent artists and crafts people cooperate to create a work of art. This fact is necessarily transferred to the learning situation, and is reflected in many of the Department's courses. Consequently, it is the Department's policy that students are required to: complete homework such as reading, line-learning, script analysis, prop lists, design drawings, etc.; attend classes; attend rehearsals both within and outside of class times; and, in short, to exhibit commitment towards the inevitably shared endeavours of our field of study.

Any student failing to fulfil these requirements is harmful to the progress of dedicated students and may, after due warning, be asked to withdraw from any individual Departmental course.

## **COURSE CONTENT NOTE**

Dramatic literature depicts a wide range of human actions, both elevated and base, public and private, physical and psychological, sexual and non-sexual, etc. Acting students must learn to simulate life truthfully in interaction with other students in the safety of the acting class and the rehearsal hall through exercises, discussions, and directions which address rather than avoid truthful, particularized, personalized action.

Much of an actor's work is based upon actual experiences of life which become translated into fictional circumstances. Because of this, the teaching of acting may involve encouraging the student to examine personal and even intimate areas of life to help him or her access life experiences appropriate to the demands of the work.

Performance classes often require strenuous physical activity. Classes may also involve physical interaction between students as part of class exercises or character development and occasional physical contact by instructors for purposes such as the demonstration of a technique or to make a posture correction. Students are responsible for wearing clothing appropriate to these activities.

Students who have concerns about dealing with the full range of actions and subject matter involved in drama are urged to discuss these concerns with their course instructor.

## **VOLUNTARY WITHDRAWAL DATES (all courses)**

The voluntary withdrawal dates for each term, without academic penalty, are:

- **FALL TERM COURSES:** November 12, 2019 for Fall courses which begin September 2019 and end December 2019
- FALL/WINTER TERM COURSES: February 14, 2020, for Fall/Winter courses which begin September 2019 and end April 2020
- WINTER TERM COURSES: March 13, 2020, for Winter courses which begin January 2020 and end April 2020
