COURSE DESCRIPTION

INTRODUCTION TO THEATRE: PERFORMANCE is designed as an introduction to the basic concepts of theatre with an emphasis on the art and process of the performer. While this class will primarily focus on the development of acting technique, this course is an introduction to the many facets of theatre. We will discuss and explore the the various creative roles in the theatre, as well tackling textual analysis and reading a sampling of dramatic literature: specifically *Bang Bang* by Kat Sandler, *New World Brave* by De Ba Jeh Mu Jig and *She Kills Monsters* by Qui Nguyen. The students' understanding of these plays and other class readings will be evaluated through brief written quizzes.

Students will also be required to attend 3 professional performances **outside of class time** in the Winnipeg Theatre community, *Bang Bang* at RMTC (Oct. 3rd -19th), *The Wedding Party* at PTE (Nov. 20th-Dec 8th) and *The Mush Hole* at MTYP (Feb 21st, 23rd & 29th) *Please note this show has 3 performances ONLY.

During both terms students will be required to take part in continuous, ongoing exercises and rehearsals privately and with classmates/instructor **outside of class time**.

Topics to be covered include:

- Improvisation
- Listening and Reacting
- Animal Work
- Creating a Character Body
- Contentless Scenes
- Monologue
- Taking Direction
- Clown Exploration
- Scene work
- Script analysis
- Working with a director/fellow actors

PREPARATION AND PROTOCOL

The standards of the profession are expected in terms of discipline and commitment. This means that everyone must arrive on time and be appropriately dressed and prepared mentally, emotionally, and physically to begin work immediately. Class time is short, we will use every minute of it. Teacher and students are responsible for a creative, supportive, and protective atmosphere in order to best serve the work. While the work in class may be exciting at times, students are reminded that respect for the work, fellow students, and the instructor is always expected. Socializing before and after classes or rehearsals and performances is part of the actor's etiquette, but quiet, listening, focus, and attention during classes, rehearsals, and presentations are absolutely necessary. Students unable to comply will be asked to withdraw from the course. The unity, creativity, and health of the class are more important than any antagonism, personal or artistic differences, temperaments, and idiosyncrasies.

Students are strongly encouraged to speak with the instructor immediately if any concerns arise about activities or climate associated with the class.

<u>Clothing</u> must be comfortable and conducive to movement. We will be rolling, sliding, climbing etc – do not wear clothing you are worried about getting dirty, scuffed or floor burned. Please feel free to bring and use knee- pads any time. Long hair must be tied back and dangling or large jewellery should be removed.

There is no food allowed in the classroom, please bring a water bottle. Students are required to keep the room clean and put away all props/rehearsal items used.

Each student must ALWAYS have a notebook and pencil. Pen is acceptable for note taking; however working with a script is a constantly shifting process so be sure to have a pencil and eraser handy.

Phones are off and away during class.

<u>Regarding Pass/Fail (P/F)</u>: A number of the performance assignments include a pass/fail component. This component is a necessary part of the process. If the student fails this component it will result in a 10% reduction in the final grade for the assignment.

Papers will **NOT** be accepted after the due date. Extensions may be granted but only BEFORE the due date and with a valid reason, at the professor's discretion. **N.B. It is the student's responsibility to retain** a photocopy or virtual copy of ALL assignments submitted for grading; in the event of loss or theft, a duplicate copy is required.

Should a student be absent (unexcused) on the day of an assigned performance, the student will receive **0%** for that assignment. Should that student's absence affect a scene partner or partners, alternate arrangements will be made for their evaluation.

Given that this is a practical studio course, extensive participation and professionalism are required. As a result, punctuality and attendance at class and at out-of-class rehearsals are of the utmost importance.

- Unexcused absences from lectures, labs, or out-of-class rehearsals will be penalized at a rate of 1% per instance.
- Unexcused lateness for lectures, labs, or out-of-class rehearsals will be penalized at a rate of .5% per instance.
- Attendance and punctuality will be recorded at the beginning of every class.
- After a <u>THIRD</u> late or absence, the instructor will schedule a meeting with the student to discuss withdrawal from the course.
- After a **<u>FIFTH</u>** unexcused absence the student will be required to meet with the Chair of the department to discuss withdrawal from the course.
- Excused absences or lates require a medical note or prior arrangement with the instructor. It is at the instructor's discretion whether or not to excuse a non-medical absence.
- After **<u>FIVE</u>** excused absences the student will be required to meet with the Instructor to discuss whether it is realistic for him/her to continue in the course.

Given the rigorous, practical nature of studio courses, and the demands these courses make in terms of attendance and punctuality, students with chronic medical conditions that require extensive absence should meet with the instructor at the beginning of the term to discuss whether the course is appropriate for them.

"THE REAL THING" LECTURE SERIES

The Department of Theatre and Film presents a series of six lectures which will be held on **Wednesdays** during the free period (12:30-13:20) in Theatre 1T15. Please note the dates in your diary <u>NOW</u>:

This series will feature speakers from a range of areas in the performing arts: technical, performance, design, management, film, directing, playwriting, etc. These speakers will specifically address issues related to "the business of the business."

Attendance at <u>ALL</u> lectures is <u>MANDATORY</u> for <u>ALL</u> Honours students in Theatre (4000-level courses, all areas), <u>as well as</u> students in: THFM-3101 Acting III: General, THFM-3201 Styles in Design, and THFM-3801 Production II. Penalties for absence may be assigned by individual instructors.

Attendance for potential Theatre Honours/Majors and for Film Majors is optional but highly recommended.

NOTES FOR PERFORMANCE COURSES

- Rehearsals for final presentations and public exercises are scheduled well in advance; students must arrange their university and work schedules so as not to conflict with them. Students must attend <u>ALL</u> scheduled rehearsals.
- Any student who repeatedly misses rehearsals, comes late, or fails to rehearse adequately will be asked to withdraw from the course (see Attendance note, above).
- As many of our classes are physical in nature, students are asked to wear comfortable clothing.
- Outdoor footwear <u>must be removed</u> before entering <u>ANY</u> of the Studios: **0T09** (Concourse Studio), **0T19** (Mime Lab), **1T15** (Theatre), **2T05** (2nd Floor Studio), **2T15** (Movement Studio). We suggest you bring suitable dance shoes or slippers to wear in class. Your professors will monitor and enforce this regulation in order to preserve the integrity of the special flooring in these rooms. Please respect this rule.
- Student actors, like professionals, are expected to provide their own basic makeup supplies where required for public exercises. Due to the potential for the transmission of skin diseases it is not recommended that students share makeup.
- Senior acting students scheduled to perform in a departmental public exercise are asked not to modify their hair colour or style without first checking with the instructor/director.

- Students who bring props, costumes, or furnishings to support scene presentations please note:
 - the University will **<u>NOT</u>** be responsible for the loss of any such materials;
 - students are responsible for the <u>IMMEDIATE</u> removal of such materials after <u>EACH</u> use the department does not provide storage;
 - materials not claimed <u>WILL BE DISPOSED OF</u> at the student's expense. Grades may be withheld until such costs are recovered;
 - students <u>MUST NOT</u> move existing furnishings from their current locations.

Activities organized by TAFSA include regular **Performance Jams, Department parties** and **Socials** as well as **DioFest** (a new play festival featuring student written and produced plays), and **24/7** (an event in which students move into our building and several plays are written, rehearsed, produced, and presented – all in a period of 24 hours!).

Please join TAFSA to find out more at its organizational meeting, tentatively scheduled for Mon Sept 16th, 12:30-13:20 pm, Room 0T10. This is a great opportunity for students to connect with other like-minded people and a way to get involved in the department events.

BUILDING SECURITY

The Asper Centre for Theatre and Film (home to the Department of Theatre and Film) is open from 8:00 am to 5:30 pm weekdays only. STUDENT PARTICIPATION POLICY & COURSE CONTENT

Theatre is a communal art form in which a number of interdependent artists and crafts people co-operate to create a work of art. This fact is necessarily transferred to the learning situation, and is reflected in many of the Department's courses. Consequently, it is the Department's policy that students are required to: complete homework such as reading, line-learning, script analysis, prop lists, design drawings, etc.; attend classes; attend rehearsals both within and outside of class times; and, in short, to exhibit commitment towards the inevitably shared endeavours of our field of study.

Any student failing to fulfil these requirements is harmful to the progress of dedicated students and may, after due warning, be asked to withdraw from any individual Departmental course.

COURSE CONTENT NOTE

Dramatic literature depicts a wide range of human actions, both elevated and base, public and private, physical and psychological, sexual and non-sexual, etc. Acting students must learn to simulate life truthfully in interaction with other students in the safety of the acting class and the rehearsal hall through exercises, discussions, and directions which address rather than avoid truthful, particularized, personalized action.

Much of an actor's work is based upon actual experiences of life which become translated into fictional circumstances. Because of this, the teaching of acting may involve encouraging the student to examine personal and even intimate areas of life to help him or her access life experiences appropriate to the demands of the work.

Performance classes often require strenuous physical activity. Classes may also involve physical interaction between students as part of class exercises or character development and occasional physical contact by instructors for purposes such as the demonstration of a technique or to make a posture correction. Students are responsible for wearing clothing appropriate to these activities.

Students who have concerns about dealing with the full range of actions and subject matter involved in drama are urged to discuss these concerns with their course instructor.
