### **COURSE DESCRIPTION**

Make-Up Lab (0T23)

This course in Theatrical Makeup combines lectures and labs, which explore the theory and application of makeup. Students will learn how to design and apply character makeup. Drawing and application skill developments are integral parts of this course.

- R. Corson, Stage Makeup (10<sup>th</sup> edition)
  - Previous editions are acceptable, though current edition is preferable.
  - E-book version is acceptable.
  - Readings from this text will be assigned coordinating with topics discussed in lecture.

# **SUPPLIES**

Each student is required to purchase his/her own basic makeup kit from the UW Bookstore. The cost of the kit is approximately \$118.00 including taxes. The kits need to be ordered by Monday, September 9, 2019. Also required: 1 HB pencil, and 1 medium blending stamp (purchase at any art supply store), and colour images taken from a variety of popular magazines.
