COURSE DESCRIPTION

This advanced course in design (sets and costumes) continues the development of design skills on both theoretical and practical projects. Students study in the capacity of design assistants or designers on Department-sponsored or approved productions.

During the first semester, students will assist the scenery, costume and lighting designer for the first UW production of the year, *Love's Labour's Lost*. They will assist in creating technical drawings, models, renderings, maintain lighting plots and other duties. The assistant will also attend production meetings, rehearsals and help the designer during technical rehearsals. While observing the designer during the pre-production and production process, the assistant will learn to communicate and collaborate with the director and other members of the production team.

With this experience, the student will undertake the design for the play '*TBD*' to be produced in the Winter term of 2019. Please see designer's responsibilities below along with the design schedule for the production. Schedule can change depending on the needs of the production.

Consequently, it is the Department's policy that students are required to: complete homework such as reading, line-learning, script analysis, prop lists, design drawings, etc.; attend classes; attend rehearsals, meetings or shoots both within and outside of class times; and, in short, exhibit commitment towards the inevitably shared endeavours of our field of study.

Any student failing to fulfil these requirements is harmful to the progress of dedicated students and may, after due warning, be asked to withdraw from any individual Departmental course.

COURSE CONTENT NOTE

Dramatic Literature depicts a wide variety of human action, both elevated and base, public and private, physical and psychological, sexual and non-sexual, etc. The Department of Theatre and Film will not undertake to censor the subject matter of dramatic works.

Students who have concerns about dealing with the full range of content and style in drama/film are urged to discuss these concerns with the course instructor.
