*Course lectures will be delivered via synchronous Zoom sessions. Practical lab components are Live in- person. *Note: Both sections will meet online via Zoom for the first class Tuesday Sept. 7 at 2:30PM

PREREQUISITE or CO-REQUISITE: NONE, although THFM-1001 or THFM-1002 are recommended.

The objective of this course is to offer an introduction to technical production in theatre concentrating on lighting and an introduction to sound for theatre and film through lectures, projects, and practical work. Emphasis will be on providing basic concepts applicable to both theatre and media. The course is divided into online lectures delivered via **online, and live in person lab sessions** during which all appropriate social distancing and Covid-19 safety work practices will be followed.

Lab sessions will offer the student the opportunity of applying the principles acquired from lectures to hands-on projects and production work related to the departmental public exercises. In addition, in order to develop a broad experience in theatre, the student will be provided the opportunity to participate in department activities beyond these supervised sessions. During lab sessions group sizes will be kept to a minimum and Covid-19 safety work practices will be followed.

COURSE DELIVERY:

Lectures will be delivered through a combination of synchronous and asynchronous instruction administered through Zoom, the course website on Nexus and Dropbox. Students will require reliable access to the Internet. Students must be available to meet as a group on Tuesdays and Thursdays from 2:30-5:15PM, via zoom for a combination of brief lectures and synchronous discussions. Lectures will be recorded for asynchronous access. These recorded lectures will be available to course members only, via Nexus, until the end of the term. Students may choose to turn off personal cameras during recording.

In-person lab sessions will offer the student the opportunity of applying the principles aquired from lectures to hands on projects and production work related to the departmental public exercises. Lab times will be during the same time as lectures but are also variable and will be scheduled to fit into the students schedule. Labs will be held with small groups and social distancing measures in place. To develop broader experience in production, additional opportunities will be available for students to participate in department projects.

POLICY ON LATE ASSIGNMENTS:

All project work and papers must be submitted on time. Late assignments will <u>NOT</u> be accepted and will be graded as zero unless prior arrangements have been made with the instructor.

TESTS:

Tests will be administered **asynchronously** (i.e. as **"take-home"** tests) Tests will be posted to Dropbox Students will have **24 hours** to submit the test via email to the instructor's email address found at the header of the document.

CRITERIA FOR GRADING IN THE LAB PORTIONS OF THE COURSE

In-person practical lab sessions are designed to introduce students to lighting equipment both in theory and practical use. During these lab sessions students can expect to learn the basics of lighting equipment with respect to how lighting systems are setup and how they are operated. Students will be instructed in proper handling of lighting equipment, hanging, cabling, focusing techniques as well as safe work practices. A more detailed description of the grading criteria will be discussed both in class and during the lab sessions.

FINAL TAKE HOME EXAM

The final **exam** will be administered **asynchronously** (i.e. as a "**take-home**" **exam**). Students will be asked to demonstrate their understanding of core concepts introduced in lectures, discussions, and assignments over the term. Date and time TBA

CRITERIA FOR GRADING PARTICIPATION

With the reality surrounding on-line classes some flexibility will be extended with regards attendance and participation. Professional conduct is expected at all times however if technological obstacles arise the instructor will work with the student to explore solutions and ensure their accessibility needs are being met.

Participation will be based on: attendance and prompt arrival (or timely and thorough communication where the current Covid situation makes this impossible), demonstrated preparation for class, positive contribution to discussion, committed engagement in exercises and projects.

- Preparation: Was the student prepared? Were they on time, having completed assignments/readings?
- Quality and nature of the participant's contributions and interactions with others: Were the student's contributions or questions relevant? Did they promote debate? Did the student respect others, listen well, and respond to others' input?

Did the student demonstrate productivity in labs and/or offer help to others?

- **Negatives**: Did the student create distractions, seek attention or appear inattentive during lectures? Did he/she engage in facebooking, texting, emailing, idle conversation and the like.

- Attendance: Students should note that missing class sessions will limit their opportunities to participate and demonstrate positive interactions. This will negatively affect the participation mark.

A NOTE RE. EMAIL AND DROPBOX

PROTOCOL

With the reality of on-line classes' reliance on technology, there will be flexibility around attendance and participation. The goal will be to work with students to make sure their access needs are met. Professional conduct is expected at all times. The instructor will work with students if frequent absenteeism or lateness becomes disruptive and explore solutions if the challenges are due to the limitations of remote learning. However, failure to meet reasonable standards of responsible behaviour in relation to classmates and instructors will not be tolerated.

In addition to the above, assignments and the production-related lab work may be estimated at not less than 25 hours for the term. This work is variable and will be dependent upon individual production schedules. Students will be advised of schedule details as they become available but should expect that such work will likely involve some evening and weekend time.

Students will be expected to have small headlamp or maglite style flashlight as well as an 8" crescent wrench for every lab session.

PUBLIC HEALTH COVID CONSIDERATIONS

In the current changing health situation, the schedule and content of the course may be subject to change on short notice. Every effort will be made to inform students of these changes, to deliver the course content in the best way possible under the circumstances, and to evaluate students fairly.

Finally, the purchase of season tickets to the Royal Manitoba Theatre Centre (Mainstage) is suggested. Our program includes the study of theatrical facilities for which we will be using RMTC and its facilities as teaching examples. It is important that you observe the techniques used as a member of the audience.

LAB DRESS REQUIREMENTS

A clean pair of sneakers or soft-soled shoes is recommended for work in lighting labs. High heeled-shoes, pumps, jewellery, and excessively baggy clothing are not permitted in the shop or in labs.

A headlamp or small maglite style flashlight as well as an 8" crescent wrench is required for lighting labs. The University of Winnipeg Theatre Dept. can provide these for students however due to covid cleaning and sanitation protocols students are encouraged to bring their own.

STUDENT PARTICIPATION POLICY & COURSE CONTENT

Theatre & Film are communal art forms in which a number of interdependent artists and crafts people cooperate to create a work of art. This fact is necessarily transferred to the learning situation, and is reflected in many of the Department's courses. Consequently, it is the Department's policy that students are required to: complete homework such as reading, line-learning, script analysis, prop lists, design drawings, etc.; attend classes; attend rehearsals, meetings or shoots both within and outside of class times; and, in short, exhibit commitment towards the inevitably shared endeavours of our field of study.

Any student failing to fulfil these requirements is harmful to the progress of dedicated students and may, after due warning, be asked to withdraw from any individual Departmental course.

COURSE CONTENT NOTE

Dramatic Literature depicts a wide variety of human action, both elevated and base, public and private, physical and psychological, sexual and non-sexual, etc. The Department of Theatre and Film will not undertake to censor the subject matter of dramatic works.

Students who have concerns about dealing with the full range of content and style in drama/film are urged to discuss these concerns with the course instructor.
