



# House Rules

## Membership

Applications for membership are submitted on the appropriate application form, but are activated only after approval by the Board of Directors. Under the terms of the Manitoba *Liquor Control Act*, instant memberships are forbidden.

Regular Membership is open to full-time Faculty and Staff members.

Associate Membership is open to part-time employees, post-doctoral fellows, graduate students, off-campus members of the Board of Regents, UW retirees, and alumni. Associate members are not eligible to vote at the AGM or other meetings of the membership.

Club Members are obliged to show their membership cards upon the request of a Club officer or staff member.

## Guests

Anyone eligible for Regular or Associate Membership is permitted a Lifetime Limit of three (3) Club visits as the guest of a Member (excluding privately sponsored functions.) This provision is in the interests of all members in good standing, and for that reason the Club's Board of Directors urges respectful compliance.

All guests must be accompanied by a Member and must be registered in the Guest Book in accordance with the *Liquor Control Act*. The sponsoring Member is responsible for the conduct of, and any liability incurred by, the guest[s].

Anyone who is not a member, a registered guest, or staff is not permitted in Club premises at any time that alcohol is being sold, served, or consumed.

Students are allowed as guests of a Member, although this membership privilege should be exercised with discretion.

During regular Club hours the number of guests on the premises must not exceed 10% of the active Club membership, as required by the *Liquor Control Act*.

Members are welcome to bring their children as guests of the Club, but young children must be supervised to ensure that their behaviour does not disturb other members and guests.

## Private Functions

Members may book the Club for private functions outside of regular Club hours. Private functions must be sponsored by a Member who must be in attendance during the entire function. If alcohol is to be served, and if the number of persons in attendance will exceed the 10% of Club membership described in 2.5 above, the event will require a special occasion liquor permit.

## Food and Bar Service

Food is available during all hours of Club operation.

Bar service is normally available between 11.00 A.M. and Closing.

Only food and beverages purchased from the Club may be consumed on Club premises.

Alcoholic beverages purchased in the Club must be consumed on Club premises.

Bookings of Club premises for meetings or special events that do not require food or beverage services may incur a rental fee.

It is expected that Members and Guests will drink responsibly and that "Designated Drivers" will be arranged as deemed necessary by Members.

The Club will arrange safe transportation home for any member or guest deemed unfit to drive. Security Services will be called to escort the individual from the Club and, if necessary, to provide that person with a taxi voucher. The Club will subsequently reimburse Security Services, and does retain the right to claim reimbursement from the individual in question.

## Common Courtesy

Cell phones should be turned off or to silent mode, and cell phone conversations should not take place in the dining areas.
